Please note that a contribution towards your cat's neutering will be required, and this must be paid before the neutering appointment can be booked with the participating vet. The contribution amount will be confirmed once we have received and reviewed your completed form. A link to make the payment will then be issued. Once payment has been made, book the appointment with one of the vets listed below and let us know which vet, date and time, and we will advise the vet that we will be covering the cost.

- £24,001–£30,000 (£2000–£2500 per month) - fee will be £30
- £30,001 - £35,000 (over £2500, less than £3000 per month) - fee will be £50
- Over £35,000 (More than £3000 per month) - we are unable to assist

Please note that payment must be made via our JustGiving page or by bank transfer. Make sure to use your pet's name as the payment reference; without it, we may not be able to match your payment, which could delay treatment.
